

THE REVEREND ROBERT B. PARKER MEMORIAL FUND

Applicants are limited to scouts from the Spirit of Adventure Council. This college assistance application is for ALL individuals either having NEVER RECEIVED THESE FUNDS or RECEIVED A "ONE TIME" GRANT. The Parker Memorial Fund and its custodians do not discriminate amongst race, color, creed, gender, or national origin, and awards are limited to maximum of 4 years of undergraduate studies only.

This 2 page application and all requested information MUST be submitted by **May 24, 2018** or it may not be considered. Any information postmarked after May 20 may not be accepted. This application MUST be submitted and accompanied by:

1. A letter in the applicant's own handwriting (not typed) stating: Why you desire a college education, influences of Scouting in your life, and why you should be granted funding.
2. A letter of recommendation from each of the following:
 - a. School representative or official; Principal/Dean, counselor, or teacher/professor.
 - b. Scout leader/Crew Advisor (previous Rev Parker fund recipients do not have to resubmit scout leader letter).
 - c. Religious leader: Minister, Pastor, Rabbi, Counselor (previous Rev Parker fund recipients do not have to resubmit letter).
3. Applicant must submit a transcript/grade report for the year's final semester. If you have not received this transcript as of May 25, please send the most recent transcript with your application, and a transcript for the year's final semester as soon as it is processed and received. It is expected that applicants hold a **minimum cumulative grade point average of 2.75** (of 4.0 point system). Therefore, only high school or college students with a 2.75 GPA or equivalent depending upon your school's grading system will be considered.
4. Copy of your college acceptance letter if you are a high school student applying. A college transcript will prove admission if you are a college student.
5. A complete copy of the federal Student Aid Report (SAR) generated after submitting FAFSA for the coming academic year including SAR page showing dollar amount of Estimated Family Contribution (EFC).
6. Applicant must be registered with the Boy Scouts of America either with a local unit or "College Reserves."
7. Applicant submits a total of six copies (1 original, 5 copies) of this application and materials **no later than May 24**.

The Reverend Robert B. Parker Memorial Fund

The Reverend Robert B. Parker Memorial Fund is intended to promote "in the Boy Scouts of America, ...through the 'Local Council', the ability of boys to do things for themselves and for others, to train them in Scoutcraft, and to teach them patriotism, courage, self-reliance, and kindred virtues". The fund was established through a trust in 1939 by Sarah Parker, Reverend Parker's widow and a woman of wealthy means. It was her desire to honor her late husband for his great commitment and interest in the youth of the St. Michael's Episcopal parish in Marblehead, as well as with all youth in the community.

Proceeds from the fund were originally intended for local Scout youth with preference to scouts from the town of Marblehead, but as the "local" council has grown over the years from the North Shore Council and now to the Spirit of Adventure Council, Scouts from many cities and towns are now eligible to apply.

The fund was originally endowed through Mrs. Parker's contribution of 900 shares of General Electric stock, an approximate value of \$30,000 and an amount that has increased in investment value to more than one million dollars today. Funding for the youth in Scouting has, for decades, been provided through the annual income from investments made by the trustees of the fund and disbursements to date have exceeded \$1,160,000.

Specific provisions of the trust include:

"Four-fifths of the annual income thereof shall be used as scholarship fund(s) to assist worthy and needy members of Marblehead Troops to obtain a college education,.....or if they deem it advisable for any other reason, such recipients may be selected from members of troops in any other part of the territory covered by the Local Council."

"The remaining one-fifth of the income shall be paid and applied in such manner as the Local Council deems will best promote the interests of boy scouts in this territory," and including a preference "for the improvement and equipment of camps and camp scholarships."

The members of the Parker Memorial Fund Committee, responsible for the selection process, are proud of all the applicants and are very pleased with the outstanding performance of the recipients. These highly qualified and deserving individuals attend many local colleges and universities, as well as some of the finest and best-known institutions throughout the country. All are good citizens and good Scouts, and continue to be exceptional ambassadors for the Boy Scouts of America!

Past recipients and all others are encouraged to donate to this fund to assist our future scouts planning to attend college, improve the quality of our camp equipment and train the camp staff, and assist younger scouts to afford scout camp. **Tax deductible donations** can be made payable to "Parker Memorial Fund" and mailed to **Spirit of Adventure Council, Attention: Rev.
